Omwille van het akkoord afgesloten tussen België , Nederland en Luxemburg betreffende de intra-Benelux wederzijdse erkenning van maritieme trainingsinstituten en de door deze instituten afgegeven opleidingsattesten voor zeevarenden, aanvaarden wij **opleidingsattesten die afgegeven door een erkend trainingsinstituut, op voorwaarde dat de betrokken opleidingsattesten zijn afgegeven in overeenstemming met het STCW-verdrag en met de geldende richtlijnen.** Het gaat hierbij enkel om opleidingsattesten die recht geven op het verkrijgen van een Certificate of Proficiency (COP) en niet om opleidingsattesten voor het verkrijgen van een Certificate of Competency (COC).

Om te weten of een door u gekozen trainingscentra voldoet neemt u zelf contact op met de Nederlandse (of Luxemburgse) autoriteiten.

Due to the agreement negotiated between Belgium, the Netherlands and Luxembourg concerning the intra-Benelux mutual recognition of maritime training institutes and the training certificates for seafarers issued by these institutes, **we accept training certificates issued by a recognized training institute, provided that the training certificates concerned have been issued in accordance with the STCW Convention and the applicable regulations.** These are only training certificates entitling to obtain a Certificate of Proficiency (COP) and not training certificates for obtaining a Certificate of Competency (COC).
